WEEK FIVE LEGISLATIVE SUMMARY Monday, February 11, 2013

Both houses worked the budget bill last week with each adopting their own amendments. Below is an outline of the mirror amendments and where they differ. The bill will go to conference committee in the next couple of weeks.

Mirror amendments:

- Wyoming Military Department increased by 2 full-time positions for a client services supervisor and a client services advocate position. \$245,812 general fund.
- WYDOT requires increased reporting under NEPA for establishing speed limits on certain roadways.
- Department of Health uses tobacco settlement funds for services at **camps for survivors of childhood cancers.** \$10,000 of tobacco settlement funds.
- Increased funding for mental health and substance abuse services \$20,500 in other funds
- Created a **Task Force on Capitol Rehabilitation and Restoration**. Also transferred money for level I and level II studies on the building. \$15,000 for task force and \$726,500 in other funds for the studies
- Requirement that agencies submit reductions of 4%, 6% and 8% in the 2015-2016 budget.
- Requires the Early Childhood State Advisory Council to report to the Joint Education Interim Committee by August 1, 2013 on the activities of the council.
- Directive to the Director of the Department of Education to consolidate reporting requirements of all school districts.
- Department of Audit conduct a baseline audit of the Department of Education \$250,000
- Audit of personnel policies and practices of the Department of Education \$150,000

### **BILLS OF INTEREST THIS WEEK**

WTA testified on three bills this week – two in support (SF 30 Special Districts and HB 170 Streamlined sales tax – direct mail) and one in opposition (HB 195 Rail tax exemption – see the comments below).

HB 69 – Highway Funding – Passing the House with a vote of 35-24-1, the bill now heads over to the Senate. The House resisted several amendments including one that targeted an increased impact towards diesel over gas; one that would have sunsetted the increase in six years; and one that would have phased the ten cent increase in over a period of 10 years, one cent at a time. HB 69 passed Senate Transportation on Wednesday with a vote of 4-1. Ideas of sun-setting the tax increase or indexing it for inflation were brought up in Committee, yet there was no support for either idea. The bill should be heard on General File this week in the Senate. WTA continues to strongly support this will and has passed out information to all of the Senators.

HB 170 – Streamlined sale tax – direct mail - The bill cleans up Wyoming's statutes as they pertain to taxation of direct mail and makes them compliant with the Streamlined Sales Tax Initiative. Support. WTA testified in support of the bill due to our long-time support of Wyoming's involvement in Streamlined. WTA also informed the Committee that the House Committee discussed the notion that it might be beneficial for Dan Noble with the Department of Revenue to give a detailed "101" on the Streamlined Sales Tax initiative during the interim. The bill passed the House with a vote of 51-9 on 1/23 and Senate Revenue with a vote of 4-1 on 2/5. The bill sits on Senate General File.

HB 195 – Rail tax exemption – extension - Extends the exemption on the imposition of state sales tax on the repair of rolling stock from 2015 to 2019. The total decrease in revenue will be \$1M. The bill passed the House with a vote of 35-25-0 on 1/28. The House amended the bill to take out the sunset and eliminated the reporting requirement. WTA testified with concern in front of the Senate Revenue Committee and asked that the sunset and reporting requirement be put back into the bill. Both were indeed re-inserted into the bill and it and got out of Senate Revenue with a slim vote of 3-2 on 2/5.

**SF 30 – Special Districts -** Requires special districts to submit proposed budgets, and requires the Department of Audit to provide reports to boards of county commissioners. WTA supports this bill. The bill passed out of Senate Revenue on 1/10/13 with a unanimous vote. The bill was amended to exclude irrigation districts (or any district that is currently under the jurisdiction of the district court). The bill passed the Senate on 1/18 with a vote of 19-11 and passed 2nd reading in the House on 2/8. The standing committee amendment to exempt school recreation districts was taken out on the floor. WTA supports this amendment.

**SF 109 – Highway and road funding – severance taxes** – This bill proposes to divert 50% of the current statutory severance tax distribution from the PMTF and distributed according to the current distribution for highway funding. Yield is approximately \$71M. Senate Revenue passed the bill with a vote of 3-2 this week and amended the bill heavily to rely on HB 69 being amended as a phased-in fuel tax and SF 109 offsetting the revenues with severance flow to meet the \$71M (amount the full \$.10 would yield annually). The bill was heard on General File last week but died with a vote of 8-22. Those voting aye: Anderson, HD (S02), Barnard, Coe, Cooper, Johnson, Meier, Perkins, and Peterson.
